壹、申請資格

Application Eligibility

凡符合下列資格者，得依本簡章向本校申請入學，經本校審查後訂定錄取標準擇優錄取。

Those who meet the following eligibility requirements may apply for admission to NKUHT in accordance with this brochure; admittance will be by merit, based on the admission criteria set by NKUHT.

申請人應不具國籍法第二條所稱中華民國國籍，且未具僑生身分者。但原具中華民國國籍，自內政部許可喪失國籍之日起未滿八年者，不得依本辦法申請入學高級中等以上學校。同一學年度不得同時以僑生及外國學生申請入學。如同時以僑生及外國身分申請入學，並經查證屬實者，撤銷其獲准之入學資格或開除學籍。

Applicants must not hold ROC nationality, as described in Article 2 of the Nationality Act, and should not possess Overseas Chinese student status. In accordance with these regulations, individuals originally holding ROC nationality and who have since renounced it shall not apply for admission to senior high schools or above if less than eight years have elapsed since the ROC Ministry of the Interior revoked the applicant's ROC nationality. If applications for admission are made using both Overseas Chinese students and foreign identities, the admission permits will be canceled or the individual will be expelled upon verification.

註一：依據「國籍法」第二條規定：有下列各款情形之一者，屬中華民國國籍：

- (一) 出生時父或母為中華民國國民。
- (二) 出生於父或母死亡後，其父或母死亡時為中華民國國民。
- (三) 出生於中華民國領域內，父母均無可考，或均無國籍者。
- (四) 歸化者。

前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

Note 1: In accordance with the provision of Article 2 of the Nationality Act, an individual holds ROC nationality under any of the conditions provided by the following sub-paragraphs:

- (1) His/her father or mother is a citizen of the Republic of China when he/she was born.
- (2) He/She was born after the death of his/her father or mother, and his/her father or mother was a national of the Republic of China at the time of death.
- (3) He/She was born in the territory of the Republic of China, and his/her parents' nationality cannot be ascertained or both were stateless persons.
- (4) He/She has undergone the nationalization process.

The provisions in the preceding subparagraphs 1 and 2 shall also apply to individuals who were minors at the time of the revision and promulgation of this Act.

註二：依據「外國學生來臺就學辦法」第2條第2項：具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者，亦得依本辦法規定申請入學。

- (一) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。
- (二) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

Note 2: In accordance with Paragraph 2 of Article 2 of the "MOE Regulations Regarding International Students Undertaking Studies in Taiwan," individuals with foreign nationality, complying with the following provisions, and having continuous overseas residence for more than six years at the time of application, may also apply for admission if they meet the following conditions:

- (1) Individuals who have ROC nationality but who have never had household registration in Taiwan as of the time of the application.
- (2) Individuals who once had ROC nationality prior to the application, but who do not have ROC nationality as of the time of application, and wherein eight years has elapsed since the ROC Ministry of the Interior revoked the ROC nationality, calculated from the date of application

具外國國籍且符合「外國學生來臺就學辦法」第2條第2項第1至3款規定（亦即兼具中華民國國籍），於申請時並已連續居留海外六年以上者，得申請入學，以上所稱海外，指大陸地區、香港及澳門以外之國家或地區。所定六年之計算，以擬入學當學期起始日期（西元2025年8月1日）為終日計算之。

Individuals who have foreign nationality and comply with the provisions of Subparagraphs 1 to 3 of Paragraph 2 of Article 2 of the "MOE Regulations Regarding International Students Undertaking Studies in Taiwan" (that is, those who also have ROC nationality), and have resided overseas continuously for more than six years at the time of application, are eligible to apply. The term "overseas" above refers to countries or regions other than mainland China, Hong Kong and Macau. The calculation of the 6 years as specified in the first proviso is calculated from the intended commencement date of the semester of admission (1st of August 2025).

具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本簡章規定申請入學。**(僅具香港或澳門永久居留資格者，請逕洽海外聯合招生委員會辦理)**

Individuals who have both foreign nationality and permanent residence status in Hong Kong or Macau, have no previous household registration in Taiwan, or have resided continuously in Hong Kong, Macau or overseas for more than six years at the time of application, may apply for admission in accordance with the provisions of this brochure. **(For individuals who only have permanent residence status in Hong Kong or Macau, please contact the University Entrance Committee for Overseas Chinese Students for application details.)**

曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本簡章規定申請入學。**(僅具大陸地區人民身分者，請逕洽大學校院招收大陸學生聯合招生委員會辦理)**

Individuals from mainland China region who have foreign nationality, no previous household registration in Taiwan, and have resided continuously overseas for more than six years at the time of application may apply for admission by the provisions of this brochure. **(For individuals who only have Mainland China nationality, please contact the University Entrance Committee for Mainland Chinese Students directly for application details.)**

前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合「外國學生來臺

就學辦法」第2條第5款所列情形之一且具相關證明文件者，不在此限：其在國內停留期間，不併入海外連續居留期間計算。

The continuous residence referred to in the preceding paragraph refers to a total of not more than 120 days per calendar year during the stay in Taiwan. However, individuals who comply with any one of the situations listed in Subparagraph 5 of Article 2 of the “MOE Regulations Regarding International Students Undertaking Studies in Taiwan” and who have relevant documentary proof are not subject to this restriction: the period of stay in Taiwan is not incorporated into the period of calculation of overseas continuous residence.

外國學生須符合教育部採認之高中、大學或獨立學院畢業者（請參考教育部國際及兩岸教育司網頁 <http://depart.moe.edu.tw/ed2500/>）。外國學生具國外高中畢業資格者，得申請入學本校學士班；具學士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校碩士班；具碩士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校博士班。

Foreign students should be graduates of high schools, universities or independent colleges, holding diplomas recognized by the Ministry of Education (please refer to the web page of the Bureau of International Cultural and Educational Relations of the Ministry of Education <http://depart.moe.edu.tw/ed2500/>). Foreign students with foreign high school graduate qualifications are eligible to apply for admission for the bachelor degree; those with a bachelor degree or students with equivalent qualifications are eligible to apply for admission for a master's degree; those with a master's degree or students with equivalent qualifications are eligible to apply for admission for a doctoral degree.

外國學生申請來台就學，以一次為限。於完成申請就學學校學程後，除申請碩士班以上學程，得依本校規定申請入學。如繼續在台就學者，其入學方式應與我國內一般學生相同。

An international student applying to study at an educational institution in Taiwan is limited to only applying once [Note: a person may apply to more than one educational institution, but if one of these applications is successful and the applicant then studies in Taiwan, they cannot subsequently apply to study at another educational institution for a program at that same level]. After completing the course of study at the educational institution to which they applied, unless the student is applying for admission to a program for a master's degree or a higher degree, which may be handled by each university in accordance with its regulations, if the students want to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students.

凡在中華民國國內遭退學者，不得再申請入學。如違反此規定並經查證屬實者，撤銷其入學資格或開除學籍。

Foreign students who have been expelled from any ROC university are not eligible to re-apply for admission. If there is a breach of this provision, upon verification, the admission qualification will be canceled or the individual will be expelled.

轉學生申請文件及截止日期等相關事宜均比照新生申請入學方式辦理，且轉學生以在臺就讀大專院校方得提出申請，於系、所審查時決定就讀年級，並於註冊入學後申請學分抵免。轉學生需於報名時繳交在臺就讀學校之在學證明，於錄取後在原就讀學校辦理退學，並於註冊時繳交

退學證明至國際事務處。

The application documents, expiration date and other related matters for transfer students are processed in the same method as those for admission applications for new students. Only students who study in colleges and universities in Taiwan may submit a transfer application, and they should apply for credit transfer after registration. The department will determine year of study. Transfer students should submit proof of enrolment issued by the institute, and apply for withdrawal after getting admitted by NKUHT. Transfer students should turn in proof of withdrawal to International Affairs Office in the process of registration.

每一申請人至多可申請三個系所，若同時錄取多志願時，本校依系統所填志願順序進行分發錄取，考生不得異議。（每一志願系所各備妥一份完整申請文件並於文件註明申請系所別）

Each applicant may apply to three departments at most. If the applicant has been accepted by more than one department, the University will allocate him/her to the department in accordance with the order of preference he/she has entered into the system. The applicant should not have any objection to this.

貳、申請方式

Application Method

一、線上報名(報名網址為: <https://examstd.nkuht.edu.tw/EnrollSTDFS/>)

報名系統開放時間：

1. 第一梯次為 2024 年 10 月 30 日起至 2024 年 12 月 13 日
2. 第二梯次為 2025 年 1 月 20 日起至 2025 年 3 月 21 日。

申請者可擇一梯次報名，若第一梯次未錄取者，可於第二梯次再次報名。報名時間截止前未將資料上傳或所附證件不齊全者，一律不予受理，亦不得申請延繳。

Step one: There are two application periods, either one of which can be chosen:

1. The first application period: 30th of October 2024 to the 13th of December 2024.
2. The second application period: 20th of January 2025 to the 21st of March 2025.

The applicant should submit the required documents by uploading to the system before the deadline. Late registrations or applications with incomplete accompanying documents are subject to being rejected, and deferred submissions are also not allowed. Applicants who apply for the first application period and are not accepted are encouraged to apply for the second application period.

二、掃描所有相關申請表件，每份文件一個檔案(學歷證件、歷年成績單、財力證明暨財力保證書、護照或身分證件、語言能力證明、清楚之證件照、相關附件、其他系所規定表件)，請依照上開順序依序取檔名，於報名梯次時間截止前上傳至報名系統，逾期不受理。所有檔案均以 PDF 或 JPG 檔案上傳，單一項目(如成績單)如有多個電子檔，請自行合併成一個檔案後再上傳。檔案不清楚者，視同資料不齊全，將不予受理。紙本資料不須郵寄，請妥善保存。申請生至多申請三個系所，一個系所繳交一份留學計畫書。

Step two: When applying online, please scan all relevant application forms, and create one file for each document (academic certificates, transcripts of academic records, financial proof and financial guarantee statement, passport or other proof of nationality, language proficiency certificate, ID photo and other documents requested). Please give each document a file name in the order mentioned above, and upload them to the system. No application will be accepted after the deadline. All files should be uploaded as PDF or JPG files. If there are multiple electronic files for a single item (such as transcript of academic records), please merge them into one file before uploading them. If the file is not clear, it will be deemed incomplete and will not be accepted. Hard copies are not required to be mailed. Each applicant may apply to three departments at most. If the applicant applies to more than one department, he or she will need to submit a separate study plan for each department.

Step three: Within one week after submitting the application documents, please check the system to

confirm your submission status. If not, it shall be deemed that the application process has not been completed yet.

Note: If you are accepted for admission, you must submit your diploma and transcripts of academic records or their translation versions to a nearby embassy, consulate, or representative office of the Republic of China for verification, and submit the authenticated diploma and official transcripts of academic records to us within the specified period after start of the school year; otherwise, your admissions offer will be revoked.

Hong Kong or Macau region shall be processed according to the Regulations Regarding the Assessment and Recognition of Hong Kong & Macau Academic Credentials.

Academic qualifications from mainland China region shall be processed according to the Regulations Regarding the Assessment and Recognition of Mainland China Region Academic Credentials. We recommend you have verified documents before applying.

（三）馬來西亞、印尼、泰國、菲律賓、汶萊、緬甸地區的申請者，可由當地的保薦單位核驗學歷及成績(保薦單位名單請見下列網址：

Applicants from Malaysia, Indonesia, Thailand, Philippines, Brunei and Myanmar can verify their academic qualifications at local authentication agencies, which can be found at the following website: <https://www.ocac.gov.tw/OCAC/Pages/VDetail.aspx?nodeid=1873&pid=23725386>).

The academic qualifications, verified by local authentication agencies, must be verified by an ROC overseas representative office after getting admitted; as for documents verified by The Federation of Alumni Association of Taiwan Universities, Malaysia, these do not need to be verified again.

Academic qualifications from all other regions shall be processed according to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education:

1. One photocopy of the education qualification verified by an ROC overseas representative office (please attach a Chinese or English translated copy if the document is in a language other than Chinese or English).

2. One photocopy of the official transcript verified by an ROC overseas representative office (please attach a Chinese or English translated copy if the document is in a language other than Chinese or English).

◎成績單須有在校每學期課程所修讀之成績且無法以研究生個人培養計畫、STPM、A LEVEL、SPM、UEC、O LEVEL 等成績取代。

Transcripts must have the course results for every semester at the school of study. They cannot be replaced by individual development plans of graduate students, STPM, A-level, SPM, UEC and O-level results.

◎應屆畢業生申請者，申請時可不須繳交畢業證書（惟需繳交在學證明書），但註冊時必須繳交，否則取消錄取資格。

Applicants need not submit the graduation certificate at the time of application (other than proof of their student status). However, it must be submitted at the time of registration; otherwise, the admission qualification will be revoked.

◎申請博士班請提供碩士畢業證書、申請碩士班請提供學士學位畢業證書、申請學士班四年制請提供高中畢業證書、申請學士班二年制請提供二年制專科學校畢業證書。

Please provide a master's degree certificate when applying for a PhD program, a bachelor's degree certificate when applying for a master's program, and a high school diploma when applying for a four-year bachelor's program. Please provide a two-year junior college diploma when applying for a two-year bachelor's program.

◎在臺曾參加海青班訓練者，學歷請填寫高中畢業學校(非以海青班為其畢業學歷)。

For applicants who have attended the Overseas Youth Vocational Training School in Taiwan, in the education section please fill in the name of the senior high school (i.e. not the Overseas Youth Vocational Training School) from which you graduated.

◎有關外國學歷者，本校得視審查需求，請申請人提具學校行事曆。

For applicants holding a foreign university degree, NKUHT may request submission of academic calendars for review if necessary.
