#### 1. LANGUAGE

The language of the conference shall be English.

#### 2. DEFINITIONS

- "The Conference" means The International Conference on "Evaluating Constitutionalism and its application in Global Governance for securing Human Rights"
- "JLU CCLHR" means the JLU Centre for Constitutional Law and Human Rights.
- "Identity" means any fact of the identity of an individual/a team/its members, or the College/University/Organisation represented by the individual/team and the state or region where such College/University/Organisation is located and includes any identification marks/ seal of the individual/team or the College/University/Organisation represented.
- "Organizing Committee" or "OC" refers to the organisers of the conference & members of the JLU CCLHR.
- "Paper" means an unpublished, original manuscript for the purpose of this Conference.
- "Participant" means a candidate submitting a paper but not presenting.
- "Presenter" means a candidate submitting and presenting a paper.
- "Team" means the structured unit of the registered participant(s)/presenter(s) of the Competition. Each team shall consist of one individual or two individuals that meet the eligibility criteria.
- "University" means Jagran Lakecity University, Bhopal.

#### 3. INTERPRETATION

The Centre will have exclusive authority to interpret the Rules in the interest of fairness and equality. The interpretation placed upon these Rules by the Organizing Committee shall be conclusive and the decision of the OC regarding the application of these rules shall be final.

- Length of full paper: Maximum 3500-7000 words (excluding footnotes)
- Font and Font Size: Times New Roman, 12; Line spacing 1.5; and Alignment: 'justify'.
- Submissions must be made in MS Word Format (.doc)/(.docx) only.
- Submissions made in any other format shall not be considered.
